



All Seasons Fund (UNAVX) Commentary  
June 2023

The All Seasons Fund ended the month of June with a return of +1.69%.

#### Market Review

Technology and growth stocks led equities higher in June, with economic data coming in stronger than expected. Q1 Gross Domestic Product (GDP) was revised higher, reflecting upward revision trends in exports and consumer spending. Further, the Consumer Price Index (CPI) and Producer Price Index (PPI) data indicated softening of inflation.

While the month's daily market moves were mild, the volatility markets provided information on how investors prepare for the second half of 2023. For example, the CBOE Skew Index (SKEW), which indicates investors' fears of downside risk, has spiked since the start of the year. In June 2023, SKEW matched its second-highest levels since its 2013 inception. Notably, today's SKEW levels reach that of September 2018, just before that year's end late sell-off, and December 2019, just before the COVID sell-off. While this lone indicator is not prescient of anything more than market fear and hedging, we believe it indicates support levels if markets do cascade lower.

The fund had modest risk versus reward opportunities converted for a positive month. We do emphasize the low correlation of the fund strategy to equities and bonds. Moreover, we have no opinion on the direction of markets in the mid or long-term. We believe there are periods of statistically compelling short-term risk versus reward dynamics that may offer a strategy with high risk-adjusted returns.

The [All Seasons Fund \(symbol: UNAVX\)](#) remained an overall FIVE-STAR (5-Star) Fund in [Morningstar's Equity Market Neutral Category](#) (out of 33 Equity Market Neutral funds) from its inception on October 13th, 2017 to June 30, 2023, based on risk-adjusted return.

Morningstar uses this step to calculate this rating:

1. Morningstar Risk-Adjusted Return: Adjust Morningstar Return for risk to get MRAR. Morningstar Risk is then calculated as the difference between Morningstar Return and Morningstar Risk-Adjusted Return.

Simultaneous with the commencement of the Fund's investment operations on October 13, 2017, the Goldman Navigator Fund, L.P., a limited partnership managed by Mr. Steven Goldman, the Fund's portfolio manager (the "Predecessor Partnership"), converted into the Institutional Class shares of the Fund by contributing all its assets to the Fund in exchange for Institutional Class shares of the Fund.

Performance data quoted prior to October 13, 2017, represents the past performance of the Goldman Navigator Fund, L.P., a limited partnership managed by Mr. Steven Goldman, the Fund's portfolio manager (the "Predecessor Partnership"). From its inception in 2002 through 2012, the Predecessor Partnership was managed as a proprietary account of the portfolio manager and was converted to a limited partnership in 2012. From its inception on February 1, 2002, through October 13, 2017, the Predecessor Partnership maintained investment policies, objectives, guidelines, and restrictions that were, in all material respects, equivalent to those of the Fund, and at the time of the conversion, the Predecessor Partnership was managed by the same portfolio manager as the Fund.

Such portfolio manager managed the Predecessor Partnership since its inception in a manner that, in all material respects, complied with the investment guidelines and restrictions of the Fund. The Fund's performance for periods before October 13, 2017, is that of the Predecessor Partnership and includes the expenses of the Predecessor Partnership. The performance includes gains or losses plus income and the reinvestment of all dividends and interest. All returns reflect the deduction of all actual fees and expenses, paid by the Predecessor Partnership, without provision for state or local taxes. If the Predecessor Partnership's performance was adjusted to reflect the projected first-year expenses of the Fund, the performance for all periods would have been lower than that stated. The Predecessor Partnership was not registered under the 1940 Act and was not subject to certain investment limitations, diversification requirements, and other restrictions imposed by the 1940 Act and the Internal Revenue Code of 1986, as amended (the "Code"), which, if applicable, may have adversely affected its performance. On a going forward basis after October 13, 2017, the Fund's performance will be calculated using the standard formula set forth in rules promulgated by the SEC, which differs in certain respects from the methods used to compute total returns for the Predecessor Partnership. The Morningstar Rating™ for funds, or "star rating", is calculated for managed products (including mutual funds, variable annuity and variable life subaccounts, exchange-traded funds, closed-end funds, and separate accounts) with at least a three-year history. Exchange-traded funds and open-ended mutual funds are considered a single population for comparative purposes. It is calculated based on a Morningstar Risk-Adjusted Return measure that accounts for variation in a managed product's monthly excess performance, placing more emphasis on downward variations and rewarding consistent performance. The top 10% of products in each product category receive 5 stars, the next 22.5% receive 4 stars, the next 35% receive 3 stars, the next 22.5% receive 2 stars, and the bottom 10% receive 1 star. The Overall Morningstar Rating for a managed product is derived from a weighted average of the performance figures associated with its three-, five-, and 10-year (if applicable) Morningstar Rating metrics. The weights are: 100% three-year rating for 36-59 months of total returns, 60% five-year rating/40% three-year rating for 60-119 months of total returns, and 50% 10-year rating/30% five-year rating/20% three-year rating for 120 or more months of total returns. While the 10-year overall star rating formula seems to give the most weight to the 10-year period, the most recent three-year period actually has the greatest impact because it is included in all three rating periods. The Morningstar ratings do not take into account sales loads.

UNAVX received Five-Star ratings for 3-year (33 funds), 5-year (32 funds), and a Five-Star rating for overall (33 funds) periods ending June 30, 2023. All in Morningstar's Equity Market Neutral category based on risk-adjusted returns.
