The All Seasons Fund was +1.79% in December and was +6.91% in 2022.

Market Review

We are pleased to report positive returns in 2022, an unusually challenging year for both equities and bond markets. Both stocks and bonds were negative for only the second time since the S&P's inception. Our existing team has spent decades building and implementing the current Fund strategy with a research emphasis on intended robustness in risk management. 2022 was a firm test of our model.

The current All Seasons portfolio management team took the lead on the Fund at the end of 2020. Our mandate was to achieve the goals stated in the prospectus objective: "The Fund seeks capital appreciation and capital preservation with lower volatility throughout market cycles – highly correlated with the Standard & Poor's ("S&P") 500® Index in bull markets, and less or negatively correlated in bear markets."

Since the current portfolio management team took the helm, we have fulfilled our Fund objective with double-digit gains in the bull market of 2021 and high single-digit gains in the bear market of 2022. However, we believe this is only the beginning of accomplishing our long-term mission. We look forward to the opportunity to meet our Fund objective with investors in the years and decades to follow.

The management team will continue to focus its quantitative research on reducing risk and decreasing correlation in down equity and bond markets. While the Fund strategy uses inputs such as (but not limited to) price movement, volume, and implied option prices to drive its buy and sell signals, we are constantly scouring the market landscape for other signals that may further benefit our return stream. Above all, we value our investors and their expectations. Therefore, we will continue to work diligently to meet the fund objectives.

Performance data quoted prior to October 13, 2017, represents the past performance of the Goldman Navigator Fund, L.P., a limited partnership managed by Mr. Steven Goldman, the Fund's portfolio manager (the "Predecessor Partnership"). From its inception in 2002 through 2012, the Predecessor Partnership was managed as a proprietary account of the portfolio manager and was converted to a limited partnership in 2012. From its inception on February 1, 2002, through October 13, 2017, the Predecessor Partnership maintained investment policies, objectives, guidelines, and restrictions that were, in all material respects, equivalent to those of the Fund, and at the time of the conversion, the Predecessor Partnership was managed by the same portfolio manager as the Fund.

Such portfolio manager managed the Predecessor Partnership since its inception in a manner that, in all material respects, complied with the investment guidelines and restrictions of the Fund. The Fund's performance for periods before October 13, 2017, is that of the Predecessor Partnership and includes the expenses of the Predecessor Partnership. The performance includes gains or losses plus income and the reinvestment of all dividends and interest. All returns reflect the deduction of all actual fees and expenses, paid by the Predecessor Partnership, without provision for state or local taxes. If the Predecessor Partnership's performance was adjusted to reflect the projected first-year expenses of the Fund, the performance for all periods would have been lower than that stated. The Predecessor Partnership was not registered under the 1940 Act and was not subject to certain investment limitations, diversification requirements, and other restrictions imposed by the 1940 Act and the Internal Revenue Code of 1986, as amended (the "Code"), which, if applicable, may have adversely affected its performance. On a going forward basis after October 13, 2017, the Fund's performance will be calculated using the standard formula set forth in rules promulgated by the SEC, which differs in certain respects from the methods used to compute total returns for the Predecessor Partnership.
